

Job Description

- Job title: General Youth Worker
- Scale: £12.02 per hour
- Hours: 16 hours per week, working over 3 days, 3pm-9pm 2 weekdays and 4 hours Saturday daytime .

Responsible to: Centre Manager

- **Responsible for:** Providing youth engagement activities, in and out of Centre, support for staff around behaviour management of young people, encouraging improved and positive behaviour and engagement from young people in youth services
- Liaison with: Centre Manager, Youth Services Manager, Qualified Youth Workers
- **Purpose of job:** To be part of a team creating purposeful, meaningful relationships with young people in the local area and to support with the development of youth activities and engagement
- Main Duties: Normal duties shall be determined by the Chief Officer and Trustees of the Association and shall include;
 - 1. To work alongside the Youth Service Manager and Qualified youth staff to develop engaging, informative and meaningful youth activities through detached and Centre based work.
 - 2. To deliver a detached programme in identified areas of need.
 - 3. To deploy the 'Youth Bus' and deliver mobile youth engagement sessions in targeted areas.
 - 4. To support Centre based 'youth club' style and issue based sessions for a variety of age ranges and needs.
 - 5. To support physical activity and sports based sessions.
 - 6. Consult with young people throughout all youth engagement opportunities to capture needs and wants of our targeted audience.
 - 7. To work holistically to help young people make personal progress around attitude and mental wellbeing.
 - 8. To manage challenging behaviour in and out of Centre when engaging with young people, be able to de-escalate heightened situations, and to develop a

behaviour management system to help young people develop consequential thinking where possible, and to help them to learn from their mistakes.

- 9. To empower young people in the notion of having aspirations for their future.
- 10. To support young people to make improved choices and decisions within the youth setting and within their wider personal lives.
- 11. To signpost and refer young people into specialist services where necessary and to offer support in engaging with these services.
- 12. To assist in the organisation and delivery of trips and visits.
- 13. To support with the running of the HAF project.
- 14. To support with the running of P.O.P within hubs, mobile provision and one to one settings.
- 15. To be professionally curious and share any safeguarding concerns with the DSL and DDSL.
- 16. To share in the responsibility of the building on a day to day basis.
- 17. To ensure that all activities meet the necessary health and safety requirements.
- 18. Drive and support delivery from the 'Youth Bus'.
- 19. Support our transport provider by following maintenance checks and procedures for the safe use of the Youth Bus.
- 20. Keep all necessary paperwork related to the role up to date, logging interventions and writing reports where necessary.

Such other duties as may be appropriate to the grade and previously agreed by the Association.
